Ss. Peter and Paul Parish Grant, 2022-23

Ss. Peter and Paul Parish will offer grants to students of Ss. Peter and Paul school to help pay tuition. This grant will be applied to a remaining balance in tuition up to the full limit of the grant. To receive this grant a student's family must ask for it. Following Easter break the parish and the school will make application forms available. A family must fill out an application form for each child and submit it to the parish office by the due date in order to receive a grant from the parish.

To receive this grant a student must:

1. Attend Ss. Peter and Paul School
2. Apply for the grant by filling out the application form

For the academic year of 2022-2023, the Ss. Peter and Paul parish grant will offer to cover unpaid tuition balances up to \$2,450.

Once a family applies for this grant then, at the end of the school year, after all tuition payments have been made and after all other funding, grant, and/or tuition assistance takes effect, this grant will cover any remaining balance up to \$2,450.

Upon filling out the Ss. Peter and Paul School Financial Commitment Contract parents will have the opportunity to check the box indicating that they plan to apply for the Ss. Peter and Paul Church Grant [K-8th only]. Upon making this indication the family will be billed according to the presumption that the student will receive this grant. However, checking this box does not fulfill the obligation of filling out the application later in the school year. If a family indicates that they will fill out an application and fails to do so, then that family is responsible for the outstanding amount due.

It is the obligation and responsibility of the parents of each student to both:

1. Commit to applying for the Ss. Peter and Paul Church Grant at the beginning of the year
2. Filling out the application at the end of the year

If a parent does not indicate at the beginning of the year that they plan to apply for the Ss. Peter and Paul Church Grant, then they will be billed according to the full amount and no refunds or reimbursements will be provided at a later date.
